HOW WE SERVED TO CHANGE LIVES

From DG ED:

After I left my very first club visit, I was reflecting on my comments and how excited I was to be able to serve 61 Rotary clubs and over 2800 members as District Governor for the 2021-2022 cycle. Having accelerated my assignment due to unexpected circumstances, I was still processing the objectives as listed by RI President Shekar Metha. The initiative that resonated the most was "Serve To Change Lives" which was accommodated by the powerful logo representing the world in the palm of our hands with many different elements in a circle, with many separate colors and parts signifying the many diverse economic and cultural circumstances that exist within our Rotary family.

As I thought about the interpretation, I had an epiphany which immediately translated the true meaning of "Serve To Save Lives" and how we as a district could the expansive impact generated by each club and collectively within D6920.

We have always reported our projects in terms of what is is, who is served, how many hours were included, and how many Rotarians participated. It instantly occurred to me that the result of the result was not being measured. In other words, how many people were ultimately impacted by our efforts? Why not measure that in a simple formula using The Four Way Test as our testimony?

For example, if 300 dictionaries were given to all third graders in an area, what is the

significance? There has to be a multiplier effect applied, which in this case, using an average of five people in a household, three children and two adults, means that this one project changed not just 300 third grade lives, but in reality at least 1500 lives would be impacted in one way or another......"Serve To Change Lives" was quantified!


I called our Chief of Staff, Paula Goodnow, and shared the idea with her to make sure I wasn't being unrealistic. With her positive response, we agreed to prepare a very simple spreadsheet for each club to populate as projects were done, and this concept gained immediate traction. Ultimately, we wanted to do an aggregated report at the District Conference in April.

Every single club jumped on board with the approach of how we would "Serve To Change Lives" and the results began appearing a regular basis. With no expectations initially, I literally was happy to know how enthusiastically the Rotarians in our district were responding. At the District Conference, we combined all the reports from our fantastic clubs, and as promised, we unveiled the aggregate lives changed over the past Rotary year..........

23,109,528 LIVES CHANGED !!!!!!!!

This is truly the power of Rotary in our district. Can you imagine what he same concept produced worldwide? SERVE TO CHANGE LIVES!!!!!! Well, coincidentally, next year's Rotary theme is "Imagine Rotary", so we aren't finished, we've only just begun......

Press Release issued to Media across the District 6920 Region:

Rotary District 6920 Impacts Over 23 million lives with service projects from July 2021 to April 2022

(ROTARY DISTRICT 6920, EAST, CENTRAL AND SOUTHEAST GEORGIA) Rotary International's "Serve To Change Lives" 2021-2022 theme has made a significant impact across approximately one third of Georgia through various service projects carried out by 61 Rotary clubs and over 2800 Rotarians in District 6920, covering the central, southeast, and coastal Georgia district regions, ultimately impacting over 23 million lives in the aggregate summary.

Created in July 2021 by District Governor Ed Presnell in tandem with Rotary International President Shekar Mehta's vision, the program consisted of measuring significant service projects, including such projects as the creation of a midwives training program and the administering of COVID-19 vaccines to seafarers passing through Georgia Ports.

"It was important to show the number of lives touched because this year's Rotary theme "Serve To Change Lives," said Presnell. "I had an idea that we could set up an informal project to measure the aggregate number of lives changed within this district and around the world."

Skidaway Island Rotary Club's model midwife training program launch has a large international reach, and saved the lives of women and children in Central America living in remote indigenous communities. Through the innovation and commitment of one of its members, Dr. Miriam Rittmeyer (MD, PhD, MPH), in collaboration with several other local clubs, Rotary International, and The Rotary Foundation, the Skidaway Island Rotary Club has helped to meet critical health needs of women and children in poor indigenous communities of Guatemala (Mayan).

Dr. Rittmeyer, as Founder and Executive Director of Phalarope (www.phalarope.org), a not-for-profit dedicated to improving the lives of women and children, partnered with Rotary Club Vista Hermosa (Guatemala) and the Skidaway Island Club to acquire a prestigious Global Grant from the Rotary Foundation. The Grant funded a pilot midwife training program in eight rural communities. Based on the success of this program, the Rotary Foundation is funding expansion into 13 additional Mayan communities.

In addition to Skidaway Island Rotary Club's project, another club's project achieved a significant global impact. International seafarers were vaccinated in Savannah starting on May 24, 2021 as part of Operation Seafarer Vaccination. The project was developed by the Rotary Club of Savannah (RCoS) in partnership with the Chatham County Health Department/Coastal Health District, Community Organized Relief Efforts (CORE),

Curogram, Georgia Ports Authority, Colonial Group, Inc., Viksniks Consultants and Maritime Bethel Savannah.

The project development was started by RCoS member Lux "Captain" Lakshman at the request of Rotary's Past District Governor, Steve Barnes, to assist citizens in India with COVID-related needs. With familiarity with both India and the shipping industry, Captain Lakshman shared that seafarers on ships, both freighters and tankers are confined to their ships in all ports of call around the world, with no access to the vaccine. This meant that many of these seamen have not left their ships in well over a year.

With 4000 ships and 75000 seafarers entering the port of Savannah annually, Captain Lakshman saw an opportunity to make a global impact close to home by using this as an opportunity to provide a means to safely administer vaccines to seafarers. The Rotary Club of Savannah took up the project of vaccinating as many seafarers as possible with various stakeholders, either by taking the crew members to the vaccination site or by bringing a team of nurses from CORE (coreresponse.org) and vaccine on board. This was done at no cost to the seafarers or the shipping companies.

CORE, the Chatham County Health Department, and Curogram joined the project as COVID-19 relief service providers to staff a mobile vaccination unit and provide COVID-19 vaccines. Patients were offered the 1-dose Johnson and Johnson vaccine.

It is estimated that 15 million lives were impacted world wide as a result of this simple vaccination effort in the Savannah harbor to ensure that shipping could continue during the pandemic.

Intl. - Update







In April, MAP partnered with some of our local DMPsupported clinics to provide electric toothbrushes. Although to some, the provision of an electric toothbrush might seem like a luxury item, the benefits extend far beyond oral hygiene and reach the root of why our Domestic Medicines Program exists.





By educating on and then encouraging the practice of good oral hygiene, beneficiaries of our program can do their part to help prevent and address an underlying cause of many chronic diseases, such as heart and lung disease and diabetes. These are diseases our program aims to address. Utilizing an electric toothbrush helps develop proper

brushing habits and is more effective than a manual toothbrush. They can erase years of plaque and build-up that can be a factor in the chronic diseases mentioned as well as tooth decay and gum disease.

Due to the prohibitive cost, our program participants would not have access to this tool otherwise. This is an example of MAP creating equitable access to healthcare through something we all use every day, a simple toothbrush.






FOUNDATION NEWS:

HERE In Photos below - - You'll find a WONDERFUL invitation from India-Vision on Wheels mobile ophthalmic van - a global grant project inauguration in India.

Background:

The cardiac screening ambulance global grant project with a budget of \$76,693.000 was supported by the Rotary Clubs of Augusta, Downtown Macon, and Kings Bay, with Augusta Rotary Club as the primary international sponsor club. The rural Kadapa district is part of the poor Rayalaseema region of Andhra Pradesh, India. Hospitals in the Kadapa district receive 200 or more patients daily with ischemic heart disease and stroke, and more than 40% of those patients have never been screened for the disease. The death rate is around 22%. Inaugurated on April 1, 2022, the "Cardia Screening Ambulance" will provide for early detection of cardiovascular disease in the rural population in the Kadapa District. Early screening, detection, and treatment will reduce mortality and morbidity, and prevent adverse socio-economic impacts on the middle and low-income families in the region.





The blindness prevalence in rural India is widely published & lack of proper medical facilities, required medical staff in villages and interior areas. Rotary Club of Guntur and other Rotary Clubs are regularly involved in the avoidable blindness program from the year 2001. Clubs conducted Eye Camps for Cataract surgeries over the years. Over the years having interacted with Thousands of patients in our eye camps we came to a conclusion that a Mobile Ophthalmic van is the solution. RC Guntur along with Indian Red Cross Society collected information about the Eye Care from National Program for Control of Blindness.







Seven D6920 Rotary Clubs supported a global grant project with a budget of \$125,676 to perform pediatric heart surgeries for 63 children suffering from congenital heart disease in Guntur (India) in honor of RI president Sekhar Mehta.

India has the highest incidence of congenital heart diseases in the world with more than 400,000 children suffering from the disease.

The "Healing Little Hearts" is a favorite program of RI president Shekhar Mehta. Using funds from the global grant sixty-three children were healed in honor of his 62nd birthday.

The project is made possible with funding from the Rotary Foundation.

As one of the goals in the new Rotary year is the development of women's entrepreneurship, <u>District 6920</u> is joining forces with D2483 in Serbia once again - to raise funds to support women entrepreneurs and their businesses by donating machines and equipment they

require in order to have more productive business.

Current women's economic empowerment interventions are not enough to overcome all obstacles facing female entrepreneurs. Emerging evidence from recent studies on different capital-based, training-based, and gender-based interventions, using randomized control trials, presents promising interventions to support women entrepreneurs.

The social entrepreneurship sector has proven itself uniquely capable of empowering women leaders in its field, and of changing the lives and welfare of all women. Women social entrepreneurs have, time and time again, made a deep impact on their work through a form of impact called "scaling deep" - overhauling unfair and unjust systems, sparking collaborative social movements, and reshaping dominant expectations, norms, and stigmas.

The International Partner in this project will be PDG Hamsa Thota from District 6920 Georgia, USA, who has already supported three Global Grants in D2483 this rotary year (two of these GG were realized under the program "Hearts of Europe Global Grants"). Just recently, five members of RC Savannah, District 6920 Georgia and two spouses in one of the project's sites visited Serbia. The visitors and their hosts enjoyed Rotary fellowship, built friendships and decided to continue their successful cooperation in Global Grants.

spread the word throughout their organizations after the fact.


PS: While this was in Governor Ed's year, you can see our "Digging Stick" in the tent so Governor Heather will know we are already Digging for her.

In 2021, the club added two Major Donor Awards (\$10,000), who were Donald Fountain and Zuber Malek.

District 6920 Governor Ed Presnell for 2021-2022 and District 6920 Governor for 2022-2023 Heather Kellen were warmly welcomed to the Glennville Rotary event, along with Hamsa Thota, District 6920 Foundation Chair.



FOWLER: Taking the Four-Way Test

"Lying lips are extremely disgusting to the Lord, But those who deal faithfully are His delight." – Proverbs 12:22 (amplified)

I started Fowler & Company in March of 2011 with a vision to help Christian business leaders build better businesses that bring glory to God.

So, I want everything I do at work and at home to bring glory to God. This brings up the topic for today's article – business ethics.

This is a tough topic. I am often amazed to find strong Christians who can thoroughly disagree on what the ethical answer is to a particular business situation. I don't want to be on the wrong side of an ethical question and it is becoming clear to me that good Christian people can disagree on these things.

Since we know that people will often disagree on what the ethical (God-honoring) choice is, I have found that the best solution is to discuss business ethics openly and honestly

inside your organization and outside.

If your goal is to create an organization full of people who will make good ethical decisions, you must discuss ethics, honor examples of strong ethics, learn from ethical mistakes and always make time to discuss situations that require difficult decisions.

In my Googling for good answers to ethical dilemmas for Christians, I ran across Rotary's Four-Way Test. I have never been a Rotarian but my dad was and I remember seeing this little plaque on his desk that had the Four-Way Test written on it.

The test has always intrigued me. Could it be a great tool to help your organization make better ethical choices? Let's dive into the Four-Way Test and see! I'll be quoting from an article written in 2017 by Mark DiGiovanni for Rotarians.

The Four-Way Test was originally drafted by Herbert Taylor in 1932. Taylor was a member of the Rotary Club of Chicago and had been asked to take over the near-bankrupt Club Aluminum Company.

Taylor created the Four-Way Test as a code of conduct for that business. DiGiovanni writes that Club Aluminum applied the test to all of its business decisions. It declined business that failed to meet the test and thrived as a result.

Rotary International adopted the Four-Way Test in 1943. The Four-Way Test starts with a preamble and then asks four questions. Here is how it goes.

Of the things we think, say or do...

- First, Is it the Truth?
- Second, Is it Fair to all concerned?
- Third, will it build Goodwill and Better Friendships?
- Fourth, will it be Beneficial to all concerned?

Is it the Truth?

Yikes. It feels like we are starting with the toughest question of the Four-Way Test. Truth is hard to come by these days. If you were not physically present and able to discuss what you saw with the parties involved, you cannot be sure you know the truth.

DiGiovanni writes that truth and facts often get confused for one another. Facts cannot be logically disputed or rejected. Facts are objective. Truth is much more subjective.

We often believe a truth based on facts we believe to be correct but then later find out the

facts were not really facts. For centuries we believed the world was flat until someone brought new facts in to dispute that truth.

It is egotistical to believe that my truth is a universal truth. Everyone has a different interpretation of the facts, mixed with their experiences and beliefs that becomes their truth. I am slooooowly beginning to understand that everyone does not have to believe my truths. Everyone is responsible for coming to their own conclusions. I am responsible for acting in line with what I believe to be true.

This is where working with others gets tricky. In organizations, we must define our values as clearly as possible and discuss those tricky areas so we can all agree that our actions are based on truth, based on the best facts we can find.

Abraham Lincoln said, "The trouble with too many people is they believe the realm of truth lies within their vision." Look at how the same news story is reported by different media outlets. The same facts are being reported on but the truths proposed by the different media are being influenced by their beliefs and biases.

We all have beliefs and biases. These are the window panes through which we interpret the world. The key is to know you have beliefs and biases and respect and listen to others' interpretations of the facts.

We must base our truths on the best facts available and be transparent. Holding back information is never in the best interest of the truth.

That was the best introduction I could do for this topic within my word limits! We'll dive into the other questions of the Four-Way Test next week.
