**Programs and Fellowship: (Mike Harris)**

Discussion of 50<sup>th</sup> Anniversary party by Mike Harris and Sheila Moody. Review of last years' winter dance expense. Discussion of fixed budget amount as compared to per plate charge. Consideration of a change in type of function to encourage better participation. Request for additional \$1000.00 (or actual cost) for preparation of historical data. Jack Kurschner suggested that response cards be sent to determine the number of participants. Rem Johnston recommended that the club pay \$60.00 per member and that each member pay \$75.00 per guest. These figures are based on attendance of 160 people. The total budget would be \$9600.00. Mike Harris further stated that while this was a lengthy discussion, it was the intention of the committee to fully advise the club of related costs and consequently not have the budget understated. Bill Hicks requested that Allen Berry shop several print shops for the best price on the copying of historical material.
