President Beverly called the meeting to order.

Minutes: A motion to approve the Board Minutes from the April meeting was offered by Mike Murphy; 2<sup>nd</sup> from Tate Simpson. Motion Carried.

### **Financials:**

**Operating Account:** Te Turner provided handouts to the Board, stated the club was in pretty good shape and wasn't spending much money. The club has a little over \$4k available and is showing positive net income.

**Charitable Account:** Te indicated we have \$4,262 in the account with \$4k allotted to the Puerto Rico project. The club used all our raised funds for Charitable Outreach.

Flag / Brick: \$6,800 in the account. TAPS budget is \$4k with the club providing \$1k.

Dues: Proposal to get back to normal starting in the next quarter. Kern Baker offered a motion for dues to return to \$225 / Quarter starting in Q1; 2<sup>nd</sup> from Mike Murphy. Motion Carried.

#### **Charitable Outreach:**

• Tate mentioned the club was able to provide \$18,625 in charitable donations to Nine (9) charities throughout the Golden Isles.

### **Fellowship / Programs:**

- June 10 White Oak excursion. Club can take 30-40 members. \$125 cost, which includes lunch.
- United Command (Golden Ray) will speak to the club in June.
- Passing of the Gavel: June 28 5:30-7 at V Pizza.

# **Special Projects:**

- 2<sup>nd</sup> Harvest: Only Seven (7) available for the event tomorrow. Need more volunteers.
- MAP event Cancelled next week.

**Membership:** James Sexton mentioned there were a high number of potential members interested in joining the club and was expecting applications to come in shortly.

# **International Service:**

- John Killgallon indicated there is a Deadline of June 30 for "Double Points"
- Hamsa Thota has brought a potential global grant in the form of a mobile clinic in India. Te Turner offered a motion to provide \$1k to the project; 2<sup>nd</sup> from Joe Leek. Motion Carried.
