Operating accounts are in good shape. Net income is approx. \$45,000. Discussion ensued to transfer to Money Market fund to earn greater interest.

A motion to engage Beverly to place income into an investment account, was offered by James Sexton. 2nd from Robbie Strange. Motion Carried.

• Members' dues in arrears were discussed: Mark Podlin has acknowledged his dues owing – and confirmed he has LOA status.

A motion was offered by Joe Leek to accept the Financials as presented. 2nd Kern Baker. Motion carried.

Rotary Foundation/International: Chip Lewis gave our Club Foundation Report, as recorded by Rotary International. All-Time giving to the Rotary Foundation from members of St. Simons Island Rotary is \$601,040.

Communications: Debbie Britt has tendered her resignation. Someone to fill this position is to be identified.

Fellowship: Kern Baker organized SSI Rotary Club Happy Hour - Ember on January 10, 4:30–6:30 pm.

Reading Rockets: A Recognition Program is being organized for March to recognize readers. More volunteer readers are needed. Readers are back in schools again in person. No more videos.

Hamsa Thota announced 3 **Global Grant Opportunities** – in Azerbaijan, Kosovo and Bulgaria. Hamsa will organize funds and will be the primary contact.
