Financials: Robbie Strange:

- Robbie reported that flag sales did well in January. Membership receivables are down to \$8,000+
- Expense in January for dues to RI and District. Meeting expense to Best Western is now paid monthly.

Communications:

Janice has drawn up a SSI Rotary Publicity package and met with Pamela Hamilton (Press releases) and Kimberly McGinnis (social media) and Beverly Trainor for discussion and implementation.

Rotary Foundation/International:

Chip Lewis gave our Club Foundation Report, as recorded by Rotary International. All-Time giving to the Rotary Foundation from members of St. Simons Island Rotary is now \$603,219. 59 members of SSI Rotary are Paul Harris Fellows..

Reading Rockets:

Reported by Kern Baker as going well – readers are back in schools including SS Elementary and Burrroughs-Molette. Assistant Superintendent Glynn County Schools Tere Miller is to present an update at the March 14 meeting. Funds will be needed to present every child a book to take home at the end of the program in May
