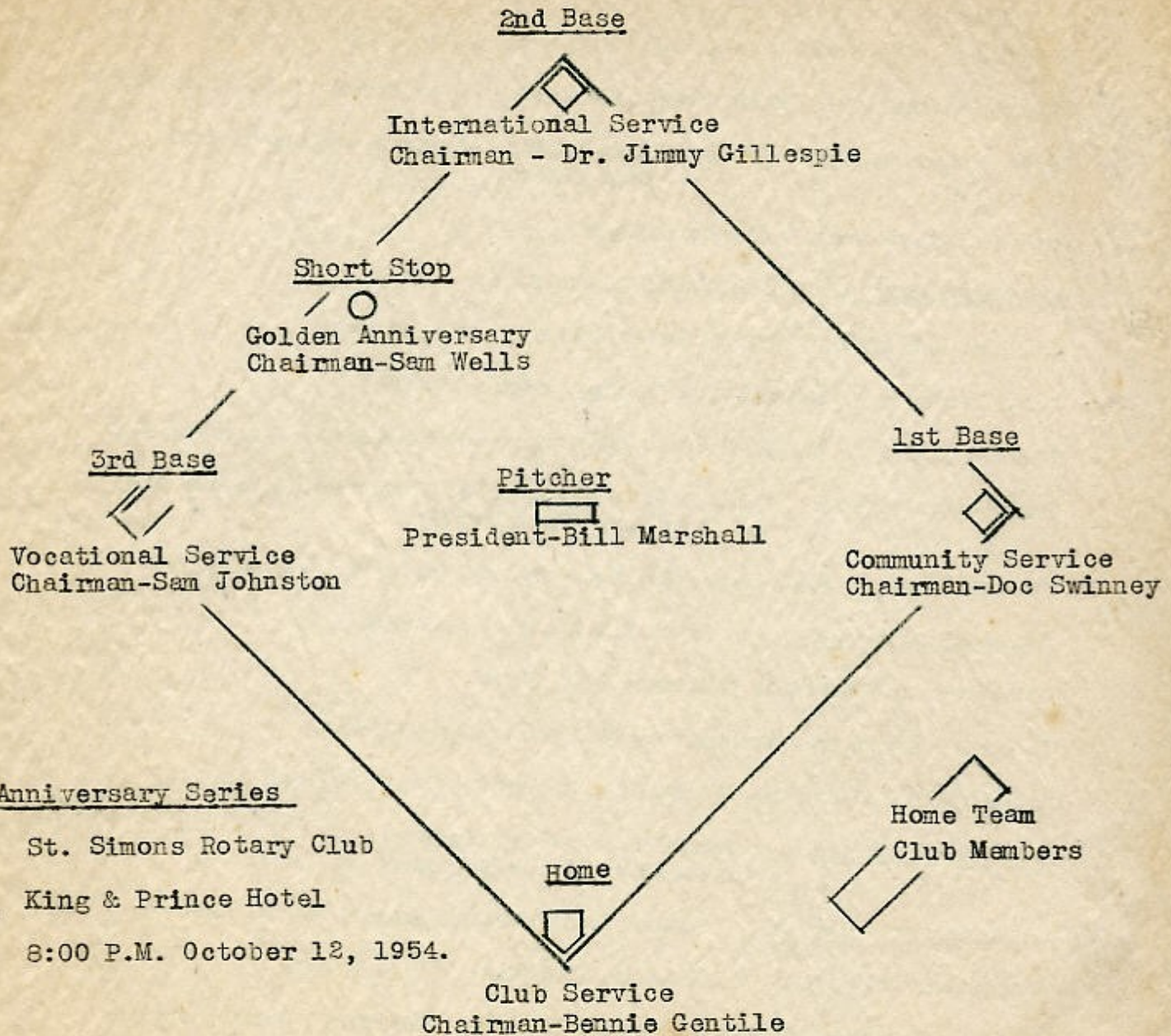

CLUB SERVICE:

Obtain a membership of 50 to celebrate 50 years of Rotary (membership was 38 at beginning of year; we obtained our 10% increase in the 1st month).

Sponsor and establish a new club in Jesup, Georgia.

Club history is being written (A scrap book with all newspaper clipping, picture of social gatherings, and other pertinent facts relative to the club have been kept since the club was chartered in 1950).

Organizing a singing group - evening rehearsals are being held.

Organized golf club - have had intercity golf match with Brunswick Rotary Club - others planned.

Planning on presenting Rotary's Golden Anniversary Book to friends and selected individuals of the community, as well as our speakers - especially during the Anniversary month of February.

Have scheduled four Ladies Night Parties - have had one cook out to date.

Plan to have District 241 Golf Tournament-two day affair with proper prizes and social events.

VOCATIONAL SERVICE:

Have a meeting at which each member brings his competitor as his guest.

One program is planned-topic "Four Way Test".

Study is being made of the community and possibility of better trade association.

COMMUNITY SERVICE:

Youth program is our biggest project. Sponsored the Sea Scouts unit. Helped to obtain a good 30' boat and motor. Our youth chairman supervises their weekly meetings and they make week-end cruises to nearby islands, etc.

Have planned a Safety Campaign for Community - literature obtained and work progressing.

We also sponsor and help financially-Little League Baseball, Midget and Junior Football teams.

We have built up a Student Loan of approximately \$1,400.00 during the last two years. We plan to give a scholarship to a worthy student their year, either in the form of a direct loan or scholarship.

INTERNATIONAL SERVICE:

Intend having class in our club in which a study is made of proposed Intra Lingua.

Plan on making an Anniversary contribution to Rotary Foundation and in conjunction have an exchange student as guest speaker each quarter.
