Child in Crisis Program

Leslie Mattingly announced that Rotarians are requested to bring a canned food item to either the Dec. 2 or 9 meeting for our **Child in Crisis** program at Altama Elementary. Alyssa Mansfield and Connie Herndon are coordinating this effort.

Members of the Rotary Auxiliary at their November meeting brought 32 Christmas gifts for elementary school children. These gifts will be delivered to the Altama Elementary School Counselor who will distribute them to needy children.

Last Week's Program: Walt Barton Sparrow's Nest



Jim Cooper introduced today's guest speaker, Walt Barton. Walt gave a brief history of Sparrow's Nest. The organization was founded about three years ago. The Brunswick Christian Community got together to respond with compassion to a wide range of needs. Pastors, ministers, and benevolent committee members who had struggled for years to assess needs and respond using limited resources decided to blend their efforts. Sparrow's Nest began. Walt commented that the churches involved have expanded from eight to thirty.

Walt described the efforts as providing help for emergency situations in a "band-aid" type approach. Direct handover of cash is not a part of the program. He spoke more specifically of food and clothing closets maintained by Sparrow's Nest. Standard hours of operation are 9-12 five days a week, with someone on call at any hour. The organization started with cash reserves only on a day-to-day basis, whereas today several months of reserves are maintained (or the specific means to obtain them). Walt talked of many specifics provided. Two of the many are: (1) providing transportation of children to day care centers while the parent searches for employment; and (2) maintaining a contact center for those without phones, for example for someone expecting a follow-up call on a job interview. The contact center is manned and has phone, fax and PC equipment.

Walt talked of the Sparrow's Nest operation in Augusta, GA, as a real success story. That organization has an 88% success rate. For example, 88 out of 100 families helped have a job, a place to live and most importantly, they are together as a family. Walt related in detail a number of specific incidents involving emergency help provided by the local organization. In closing, he answered questions from the audience and provided brochures including contact information.

The Rotary Minute

Prior to today's program, Dick Wicker presented the third in a series of these talks - his topic was, *The Rotary Foundation.* Quoting Dick, "The foundation was created in 1917 and provides health care and supplies, clean water, food, job training and education, particularly in developing nations. Additionally, large scale 3-H grants are given to support long-term projects that help others to help themselves. Finally, Rotary members contribute their own technical expertise and each year the foundation provides over 200 grants to fund Rotary volunteers in 50 countries.
