Don gave us an excellent report on the changing status of the U.S.newspaper industry. Many independent papers, large and small, are no longer being published. Others are being absorbed into large corporate structures which are involved not only in the newspaper business, but also in book publication, radio and TV broadcasting and other means of disseminating news and information. On the other hand, absorption of a local newspaper has not necessarily changed its original philosophy or editorial policy. Unlike other countries, newspapers in the U.S. are not owned by special interest groups or government; therefore they serve the public, preserve democracy, assure our future freedoms and make this country a better place to live.
