## Last Week's Program (June 14, 2005) Daniel Parshley Glynn Environmental Coalition



Marie Dodd introduced Daniel Parshley of the Glynn Environmental Coalition (GEC). Mr. Parshley's slide presentation addressed specific issues, sites, etc.

The GEC is a community nonprofit organization whose mission is to assure a clean environment and healthy economy for citizens of Coastal Georgia. The organization began providing technical services and educational speakers in 1989. Since then, the focus has expanded to include governmental oversight and environmental justice. Mr. Parshley discussed 18 sites, 8 of which have been cleaned, 6 are in progress, and 4 are under investigation. He showed a number of visuals (e.g., graphs and photos) giving evidence to accomplishments, work in progress, and work that lies ahead. He discussed in detail the four Superfund Sites: Brunswick Wood Preserving, Hercules 009, LCP Chemicals, and Terry Creek.

GEC campaigns, in addition to the Superfund Sites, include Air Quality, Water Quality, and Education. Among the GEC accomplishments are the removal of "toxic and endocrine disrupting chemicals from a neighborhood, an elementary school, and a daycare center."

Daniel discussed the Seafood Safe Consumption Campaign. The campaign will teach the locations of local fish consumption advisories, the kinds and numbers of fish that may be safely eaten, and how to best clean and prepare them. The first phase of the project has been completed — a chart in color providing information for: contamination by fish size and age; fish cleaning and cooking techniques to reduce risk; seafood advisory areas; and the kinds and numbers of fish which may be eaten safely during a one-month period. The charts were made available to all present.

Daniel concluded the informative presentation with a lively question-and-answer session.
