Marie Dodd introduced Heather Heath, Executive Director, Golden Isles Arts and Humanities Association (GIAHA). Heather moved to Brunswick in 1998 from Atlanta where she worked as a professional actress. She continues to act: 2006 in Beckett's *Happy Days*; 2005 in *Private Lives*; and 2004 in a one-woman show about Fanny Kemble. She directs the annual production of *A Christmas Carol* for the Golden Isles Community. Heather has degrees from Oxford College of Emory University and FSU. She is active in several areas of community and state arts and humanitarian organizations. Heather is married to the Mayor of Brunswick, Bryan Thompson and is President Elect of the Brunswick Rotary Club.

Heather began by explaining why she is involved in GIAHA and defining why arts and humanities are an essential part of our lives. She emphasized their importance on young people, teaching them among other things to think creatively and work with others. She discussed data from the "Americans for the Arts" group and the *Creative Industries*. She reviewed the GIAHA mission statement and its events. Among the events and activities discussed were Jazz in the Park, Performing Arts Series (including *The Sounds of Silents*, *Steamboat Bill Jr.* and *The Kid*), Art in the Ritz Gallery, Arts in Education, Special Events, and Performance and Event Management. Heather discussed the second phase of renovation of the Ritz Theater and throughout the presentation listed and explained specific benefits of arts and humanities; e.g., the \$134 billion economic activity generated in our country. She concluded her informative program with a Q&A session.
