District Governor Bill Blankenship



Assistant Governor Clyde Taylor introduced District Governor Bill Blankenship. Clyde presented Bill's bio and listed his numerous activities and roles in Rotary; Bill joined Rotary in 1991. He served in applied meteorology and oceanography in the US Navy, was Director of the St. Mary's Public Library, and currently owns the Georgia Fence Co. with his brother.

Bill first relayed greetings from Rotary International President Bill Boyd. He listed four goals of interest to the President: membership growth, our Rotary Foundation, literacy, and entertainment (helping others). Acronym = MOLE. Governor Bill presented some worldwide statistics, including an illiteracy rate of 67%, no roof over their heads 50%, no clean water 37%, and 99% no college education. These are challenges for Rotary. Bill recounted some of the SSI Rotary projects and summed up his critical analysis of our club as. "wonderful." Bill discussed the Mercury Hybrid project and asked each member to purchase at least one ticket for the drawing. He discussed the Four-Way Coloring Book and the benefits of its distribution, wells for drinking water, eradication of the Guinea Worm, and the exponential benefits of the Group Study Exchange Team programs. Another new acronym: SEA, for Self Example and Ask (ask someone to attend Rotary). President Pat presented Bill his gift from our club: four Mercury Hybrid raffle tickets.

James Shannon III

James Jordan Shannon III, "Bump", age 53, died Wednesday, October 4, 2006, at the William Breman Jewish Home in Atlanta, Georgia. As the son of a U.S.A.F officer, Jim was born at Eglin A.F.B., Florida, and moved several times to Air Force bases throughout the country and the world. Jim is a graduate of Plattsburgh High School in Plattsburgh, New York. He is also a graduate of Georgia Tech where he obtained a degree in Civil Engineering in 1975. While at Georgia Tech Jim participated in Air Force R.O.T.C. and was commissioned as a Second Lieutenant upon graduation. He was also a member of Sigma Phi Epsilon Fraternity. Jim retired from the Air Force in 1977 because of a service related disability. He has made St. Simons Island, Georgia, his home for the past 26 years.

Jim is a member of the St. Simons Rotary Club and a Paul Harris Fellow, the Georgia Tech Alumni Association, the Military Officers Association of America, and the Air Force Association. Jim enjoyed travel, photography, sports, and sharing in the lives of his nieces and nephews.

Mr. Shannon is survived by his mother, Frances S. Shannon of St. Simons Island, Georgia; his sisters Dawn S. Cannon of Waynesville, North Carolina, and Ann S. Jackson of Peachtree City, Georgia as well as his brother Michael Shannon of Fayetteville, Georgia; eight beloved nieces and nephews Jennifer Cannon of Bethesda, Maryland, Nicholas Shannon of Jacksonville, Florida, Ned Cannon of Macon, Georgia, Rebecca Shannon of Louisville, Kentucky, Stephen Jackson of Atlanta, Georgia, Katie Jackson of Atlanta, Georgia, Patrick Shannon of Fayetteville, Georgia and Sarah Jackson of Peachtree City, Georgia.

A memorial service will be held at 11:00 am, Saturday, Oct. 14, 2006, at St. Simons Island Presbyterian Church with the Reverend Robert Brearley officiating. Internment will be at a later date at Arlington National Cemetery, Arlington, Virginia.
