Jerry Keen Majority Leader Georgia House of Representatives

Rep. Keen said the state's economy is the "strongest it has been in modern recorded history."

Georgia is the fourth fastest growing state, he said, and if it were a country, it would have the 17th largest economy in the world.

"Overall, it is a great time to be in Georgia," he said.

And he predicted that the next 10 years will be the "brightest on record" for Glynn County, noting the record tonnage handled by the ports in Brunswick and Savannah, and the recent selection of a company to do a redevelopment of Jekyll Island costing more than \$400 million.

The majority leader also talked about his tax reform proposals, which involve abolishing the school portion of property taxes and replacing it with a statewide sales tax.

He said Georgians should at least have the opportunity to vote on his proposals, which he called "the largest task I've ever been involved in."

He acknowledged that passage of the proposals "will be very difficult."

Rep. Keen is serving his fourth term in the Georgia House, representing District 179 in Glynn County.

He has introduced legislation to reduce property taxes, eliminate the state income tax on capital gains, and provide tax credits for green space preservation.

He serves on the Rules, Appropriations, Ethics and Insurance Committees, and was re-elected by the Republican House Caucus to serve a second term as House Majority Leader. In addition, he is a board member of the St. Simons Land Trust, Golden Isles Arts and Humanities Association, and the Georgia Tech Advisory Board.

As a native and lifetime resident of Georgia, he and his wife Alice live on St. Simons Island. They have two sons and six grandchildren.

He works as a financial advisor for Synovus Financial Management Service.
