July 22, 2008 District Governor Kenan Kern

New District Governor Kenan Kern noted that International President Dong Kurn Lee wants all of Rotary to "help reduce the loss of children's lives."

"Your club has already been committed in this area," he said. He emphasized the need to "stop polio now" and for every Rotarian to contribute at least \$100 per year to the Rotary Foundation.

Governor Kern also announced establishment of The Blankenship Cup, named for the late district governor, which will be presented to the club with the highest average member contributions over the past year to the Rotary Foundation.

And he revealed that the Ferst Foundation, an offshoot of entertainer Dolly Parton's effort to improve childhood literacy, is in discussions with the country singer to do a benefit concert at a Valdosta theme park.

A native of Statesboro and a graduate of Georgia Southern University, Kenan served three years in the Army before returning to his hometown to begin a career in human resources management.

Following a 32 -year career as a corporate executive, Kenan founded The Kern Group, which recruits educators for school systems, and provides business consulting services.

Kenan joined Rotary in Abingdon, Virginia, in 1988. He came back to Georgia and joined the Rotary Club of Savannah South in 1993, where he served as president in 1997-1998.

He was an assistant governor in District 6920 for three years and then was a district director for three years.

The Georgia Rotary Student Program has named him a Will Watt Fellow and a Hue Thomas Fellow.

He is a multiple Paul Harris Fellow, a member of the Paul Harris Society, and a Benefactor to The Rotary Foundation. He was selected as the Rotarian of the Year in 2000-2001 from the six Rotary clubs in Savannah.

Kenan and his wife, Beth, are the proud parents of a daughter, Mary Beth Kern Haynes, and three grandchildren, who live in Effingham County.
