Program: January 10, 2012 The Honorable Lisa Godbey Wood Chief United States District Judge for the Southern District of Georgia

What eloquence! What insight! The St. Simons Rotary Club was treated to an extra special presentation by Judge Lisa Godbey Wood on January 10th! Judge Wood, who serves 43 Georgia counties in the Federal Court System, is quoted as saying..."I am not here to be lenient, I am here to be fair."

Judge Wood's speech was a compelling history lesson into the unique dynamics of United States Constitution and how it frames her job as a Federal Judge, and for all judges who serve this land. Judge Wood spoke about the succinctness of the Constitution (just 4 pages and 5,000 words) and how through preservation and interpretation, this stellar document shapes the way we think, live and conduct ourselves as citizens of this country. Remember life, liberty and the pursuit of happiness. She spoke to us about the amendments to the Constitution, why many of them were created, and how she works within the structure defined by these amendments. every day of her job. She sited Marbury v. Madison as perhaps the most important landmark case in United States law and in the history of law worldwide. She described how Marbury v. Madison formed the basis for the exercise of judicial review in the United States under Article III of the Constitution. citing that it was the first time a court invalidated a law by declaring it unconstitutional – helping to define the 'checks and balances' system of our government.

She also cited the 1954 decision *Brown v. Board of Education* where, through the legal acumen of attorney Thurgood Marshall, it was decided that 'separate but equal,' as it relates to racial division in U.S. public school systems, is in fact, not equal. It was a very thought-provoking speech, reminding us all how incredibly brilliant our United States Constitution truly is. Thank you, Judge Wood, for sharing your insight, knowledge and experiences with us.
