Classification Talks: Beverly Trainor; Mike Flores ...continued from page 1

Currently a financial advisor with Edward Jones, Beverly has enjoyed a long career in finance going back to early beginnings in Connecticut as an analyst with Paine Weber. "I had a brilliant but tough boss at Paine Weber, so that helped whip me into shape," she confessed. Beverly and husband Brian have also been retail bookstore owners for 12 years of the *Bookmark* on St. Simons. Always in search of something new and exciting, Beverly has produced an opera, climbed tall mountains, flown an airplane and dabbled in painting. At 48, she took up riding which included jumping. This passion resulted in a severe injury to her hand and arm which has required years of therapy. "However, I got back on the horse and have since enjoyed a more gentle trail riding experience in the North Georgia Mountains," she joked. We congratulate your passion for a challenge, Beverly. Keep up the good work!

Jerry then introduced longtime St. Simons Rotarian and banking consultant Michael Flores, who showed up to give a classification talk but didn't, and instead, used us as guinea pigs to practice a speech that he will give in three weeks to the Consumer Financial Services Association conference on Paradise Island, Bahamas.

Mike's presentation was about evolving trends in banking and how technology and a weak economy is changing banking as we know it, and profitability for banks in general. He singled out how recent government regulatory legislation has affected banks' ability to charge for overdrafts, greatly limiting a key revenue stream and profits by billions of dollars. He cited how the number of banks in the U.S. is dwindling – from over 12,000 in 1995, to just 7,300 in 2011. And, there will be fewer still. The real estate debacle has had huge effects on banking not only because of losses from bad debts and foreclosures, but also because making real estate loans has historically been a premier revenue generator for banks, especially for smaller institutions in small markets. He talked about how bankers are re-evaluating customer relationships as the cost of doing business with the average depositor has increased exponentially across the country. "It costs a bank an average of \$300 per year to offer and maintain a simple personal checking account," he cited. "What this means is that we can all expect higher fees for banking services in the future. Big banks are getting bigger, and smaller banks are going away. You won't recognize banking 20 years from now." We all hope we're around to see that Mike!
