Last Week's Program: April 3, 2012

Millard Allen: The State of the Glynn County Schools System

Millard Allen, member of the Board of Education, opened the program. The underlying theme of his talk was positive even though tax revenues are down, affecting the school budget in a significant short fall of some \$13 million dollars. The reasons? **1**. Increased number of students (presently 13,000, up from 10,000 in 2007), **2**. Decreased tax revenues due to depreciation of property values (as much as 50%) resulting in lowered tax bases, and **3**. Georgia Senate Bill 486 which allows tax forgiveness to seniors over 65 years of age. The bill called for under a \$40,000 *gross income*; what was passed by the Georgia delegation was a qualifier based on *net taxable income*. The result to the tax role has been significant.

Consider the following: The Glynn County School System currently serves 13,000 students, has 1,800 employees including 1,100 teachers, services 10 elementary schools, 4 middle schools, 2 high schools (including Brunswick High School which is currently getting a new facility now under construction paid by E-SPLOST), and recently added the Golden Isles Career Academy a few years back. All is maintained by a proposed budget of \$108 million dollars. Current tax revenue this year is \$99 million, with predictions for the next school year at just \$95 million. With a budget of \$108 million, that's a short fall of approximately \$13 million. That's a problem. The solution? Raise taxes. With a one mil decrease in millage rate since 2007, it isn't hard to figure out that something has to be done pretty quickly to reverse the negative economies. Another solution? Start making some tough decisions about cutting significant programs and/or staff at the school level.

In spite of the facts, Millard remains optimistic. "We haven't cut programs like other school systems such as Camden County," he reminded us. "We continue to maintain quality in our facilities, our athletic programs, and our arts programs." Thank you Millard for reminding us that each has a part in maintaining quality education in our community.
