Last Week's Program: June 19, 2012

Gift-Giving, Rotary Style A Report of the Charitable Giving Committee Mary Beth Wester, Leslie Lamkin and John Gibson

The topic for our luncheon presentation on June 19th gave us a unique chance to pat ourselves on the back for giving to the Golden Isles community in so many valuable ways. Committee Chair Mary Beth Wester opened the program by thanking Ted Wright for his distinguished performance as chair of Charitable Giving the two years prior to her chairmanship. "Ted did an extraordinary job, and as a result, made our job so much easier this year," Mary Beth reported.

Supported by committee members, Leslie Lamkin and John Gibson, the three made an impressive presentation utilizing PowerPoint (*thanks to Jett Lamkin*), outlining our club's charitable giving which includes seventeen different organizations and initiatives, among them, \$5,000 allocated for our own Bruce-Tharp Scholarship Fund. The selection committee organized our charitable giving into three distinct categories: International Charities, Adult-Based Charities, and Child/Education Based Charities. In all, an astounding \$25,000 was ear-marked for donations that literally covered the Golden Isles – the most we've ever given to the community in a single year!

How did we do it? We raised more money than ever before! – \$17,000 from our two McGladrey-based events last fall – Meet the Pros and Swing for Kids Golf Tournament, \$3,000 from club contributions, and a very generous gift of \$5,000 from fellow Rotarian, Bill Abel. Thanks so much Bill!

With a list too long to mention here, recipients of our gifts included Marion Missions, a clean water humanitarian project supported by fellow Rotarian Charles Lewis; Chaing Mai Thailand Rotary Club, also for clean water; Hospice of the Golden Isles, whose president is fellow Rotarian Bob Brearley; International Seafarers Center; Baby Steps; Boys & Girls Club of Southeast Georgia; Coastal Coalition for Children, whose president is Rotary President-Elect John Matthews; and a host of local school based projects including educational programs at Glynn Academy, Brunswick High, St. Simons Elementary, Goodyear Elementary, and Altama Elementary. The committee even left a reserve of \$3,925 to jump start next year's charitable giving program.

Thanks to all who made every part of this program so worthwhile including the charitable giving committee and every St. Simons Rotarian who supported important club initiatives mentioned above. What a great ending to another rewarding year for the St. Simons Island Rotary Club!
