Transportation Special Purpose Local Opinion Sales Tax David Hainley

Community Development Director for Glynn County

The Special Purpose Local Option Sales Tax for transportation will come before voters on July 31. The Glynn County Commission wants to make sure the community is educated on its purpose. The Transportation Investment Act (TIA) was passed by the legislature in 2010 as a means to address construction funding for transportation projects. The TIA establishes twelve regions across the state and provides for a 1% sales tax to be added on a regional basis. Counties within a region cannot opt out of the tax if approved in the region. The tax would run for a maximum of ten years or until the funds required for construction were raised. The projects to be funded were identified by all jurisdictions within the region and the final selection was made by the County Commission Chairman and a Mayor from each County. Glynn County has thirteen of the seventy-five projects within the region.
