Last Week's Program: August 14, 2012 Robert H. (Bob) Griggers District 6920 Governor

We have the annual pleasure of having our District 6920 Governor speak to our club about the 'bigger' picture of Rotary. It's always inspirational to hear as sometimes we all get so focused on our St. Simons Island and Glynn County programs, we forget there is a whole state, country and world of Rotary just beyond our horizon. Such was the case with our speaker Bob Griggers, who graced the podium at Bonefish to bring us up to speed on major new initiatives in motion with Rotary International and our new president, Sakuji Tanaka, who hails from Yashio, Saitama, Japan.



"Why am I here? Griggers asked. "This year's international theme is *Peace through Service*. What does that mean?" Griggers asked. Griggers talked about all the creative ways

Rotary is working to 'bring peace' around the world in countries where poverty and disease is rampant and safe drinking water is a luxury, if existent. He talked specifically about President Tanaka and his immense generosity to Rotary as a humanitarian and a donor, having personally given over one-million dollars of his own money to Rotary. "Tanaka is 'a doer' who gets in the trenches, literally, to dig a well or build a shelter where it's needed most."

"Rotary works hard to help the impoverished, and at the same time give people their own sense of personal dignity," offered Griggers. "People want help, but only so much so they can help themselves. That is key. We are a generous organization. But, the most valuable thing we can give people, is our respect."

He reminded us that Rotary is ever-strong world-wide. "We do not have a problem attracting members. However, member retention is a problem, largely due at present, to a weak world economy." Rotary International's aggressive goal is to grow membership by 3% in the 2012-2013 year. That growth will depend on each club embracing this goal—here on St. Simons, and at over 34,000 Rotary Clubs around the globe! He congratulated our club for its size, achievements and strength. We have a lot to be proud about. Thanks District Governor Bob Griggers for reminding us.
