October 30, 2012 Program Dr. William ("Skip") Mounts Future Economics and the Election

Dr. Skip Mounts was introduced by Marie Dodd. Mounts is the Dean of the School of Business and Public Affairs at the College of Coastal Georgia, as well as a Professor of Economics. With three degrees from UGA, economics expert Dr. Skip Mounts comes with some savvy credentials. As President Dr. Valerie Hepburn conveyed when he arrived at the Brunswick campus some 18 months ago, "with his distinguished career as a professor of economics, his experience as a Dean and Director of a respected MBA Program and his success in business school accreditation, Dr. Mounts brings a wealth of talent to the College of Coastal Georgia and the community."

It was pretty evident from his second PowerPoint who Dr. Mounts will vote for on November 6th – but just guessing, it probably will not be the incumbent. Dr. Mounts made it crystal clear that based on his expert understanding of how a national economy should operate, the Obama administration has created a "new model" for directing the Federal Reserve and the economy in ways never before experienced in U.S. history. And, according to Mounts, it's not good.

"Obama simply doesn't seem to grasp how our national economy should work," he stated. "Obama reminds me of a guy who has learned everything he knows about running an economy on the internet."

Anyway, Mounts also talked about the National Bureau of Economic Research (NBER) which objectively monitors economic indicators including national unemployment statistics. According to Mounts, the current administration's figures on new jobs don't add up to what the NBER reports as significant to real positive economic growth.

He also referred to the "big gap" in the current economic growth cycle compared to accepted historical growth indicators. According to Mounts, "we're certainly not in a positive growth posture. The Fed has purchased 77% of the new treasury debt since 2008. As a result, our economy has never had this much liquidity... If the most important goal of a business is to manage cash flow, it is evident that the Fed is working in the wrong direction."

"What lies ahead?" he asked. His guess is rampant economic inflation, the likes of which we have seldom seen!

Regardless of where your political inclinations are for November 6th, Mounts served up some pretty compelling food for thought. Thank you Dr. Skip Mounts for your most revealing presentation.
